# Ronald W. Hepburn's Works: A Bibliography

Preliminary remarks: several of Ronald W. Hepburn's papers were published more than once in different academic journals and anthologies. The following bibliography provides details of his works only in their last published locations, with the date of the first appearance in square brackets wherever applicable. This bibliography does not provide his unpublished conference talks, nor the translations of some of his papers.<sup>1</sup> Hepburn's two collected volumes mostly comprise earlier published essays (some of them were reprinted as revised versions). I mark with \* those papers which came to light again in his *Wonder*' of 1984, and with \*\* that reappeared in *The Reach of the Aesthetic* of 2001.<sup>2</sup>
